I WISH TO BRING TO YOUR PERSONAL ATTENTION A
CONSTITUTIONAL CRISIS FACED BY YOUR DEPARTMENT
AND THE COUNTRY, THAT IS, THE UNITED KINGDOM.

ALLOW ME TO START BY CITING A QUOTE FROM A
PREVIOUS COURT OF APPEAL HEARING.

" OPEN JUSTICE PROMOTES THE RULE OF LAW. CITIZENS
OF ALL RANKS IN A DEMOCRACY MUST BE
SUBJECT TO TRANSPARENT LEGAL RESTRAINTS,
ESPECIALLY THOSE HOLDING JUDICIAL OR EXECUTIVE
OFFICES. PUBLICITY, WHETHER IN THE COURTS,
THE PRESS, OR BOTH, IS A POWERFUL DETERRENT
TO ABUSE OF POWER AND IMPROPER BEHAVIOUR "

A CONSPIRED SILENCE BY THE MEDIA IN THIS COUNTRY
HAS AIDED THE JUDICIARY IN COMMITTING A CRIMINAL
ACT OF PERVERTING THE DUE COURSE OF JUSTICE.

THE CRIMINAL ACTIVITY OF THE JUDICIARY HAS CAUSED
MY WRONGFUL CONVICTION AND IMPRISONMENT WITHOUT

THE RIGHT TO APPEAL.

THIS IS NOT A MISARRIAGE OF JUSTICE, THE JUDICIARY
HAS ACTED WITH THE SOLE INTENTION OF SECURING
MY WRONGFUL CONVICTION AND IMPRISONMENT, AND HAVE
PREVENTED ME FROM HAVING ANY ACCESS OF APPEAL.


AS THE SECRETARY OF STATE WITH THE RESPONSIBILITY
FOR CONSTITUTIONAL AFFAIRS, INCLUDING JUSTICE, RIGHTS
AND DEMOCRACY, THE BEHAVIOUR OF THE JUDICIARY,
IN THE PERFORMANCE OR PURPORTED PERFORMANCE OF
ITS DUTIES, FALLS WITHIN YOUR REMIT.

THERE IS NO GREATER THREAT TO JUSTICE, DEMOCRACY
AND THE RULE OF LAW THAN WHEN JUDGES, ENTRUSTED
WITH OVERWHELMING POWER, DELIBERATELY ACT TO
PERVERT THE NATURAL COURSE OF JUSTICE INTENDED
BY LAW.

THE CRIMINAL ACTIVITY OF THE JUDICIARY IS NOT LIMITED
TO PERVERSION OF JUSTICE, IT INCLUDES, BUT IS NOT
EXHAUSTIVE, FALSE IMPRISONMENT, PERJURY, CONCEALMENT
OF EVIDENCE, AIDING, AND ABETTING AND CONSPIRACY

UNLESS YOU AND YOUR DEPARTMENT IS TO BECOME AIDERS
AND ABETTERS TO THE ABOVE CRIMINAL ACTS, THIS MATTER
IS OF THE MOST EXTREME URGENCY.
