


Statement of Caul Grant (JC8360)

1. I would like to refer the Parole Board to my previous statement given with the initial application for parole and remind them and all those who receive this document that, the only reason I accepted to activate the process of parole, then and now, is because of the opportunity to once again bring to attention the circumstances of my **wrongful conviction and false imprisonment**.
2. As a result of the Board's failure to act according to the law governing all Public Authorities, I add the following statement.
3. **The Judiciary of England & Wales and all branches of the Criminal Justice System, including the Parole Board and members of the Legal Profession are all guilty of the most severe perversion of Justice imaginable and are Aided and Abetted by the Government, Parliament and a conspired silence of the Media.**
4. All the above mentioned, are complicit in the act of knowingly securing wrongful convictions, false imprisonments, denial of access to justice and an attempt to cover up the death and circumstances leading up to the death of my 14 Month-Old Baby Boy. As a result of the available magnitude of evidence that supports this statement, I fear the State may try to kill me in its desperate attempt to suppress the Truth.
5. I am unable to get any level of Impartiality, Independence or Fairness as is guaranteed by the Rule of Law. Any system or process that lacks integrity also lacks honour and is not deserving of any level of respect in any society governed by the rule of law.
6. I want to go on record, yet again, and make it abundantly clear that I absolutely detest violence. Those who believe and possibly hoped that I might turn to violence, only do so because of the trust they themselves place in causing harm to others.
7. **It is, obviously, easier to turn wise men into fools than fools into wise men.** It would be wholly foolish and unwise for me to risk the loss of public support for a perfectly legitimate and worthy cause by enlisting the use of unnecessary violence. Non-violent actions of protest have been tested and proven over many centuries; it is the weapon of the powerless. Those who are wise will already know that the threat of violence can be used as a tool without any actual use of violence. The threat of violence can be used to avert destruction whilst violence can only destroy.
8. Even if the State does kill me, which is its next option in the level of violence levelled at me and my family thus far, it would not be possible to kill the Truth. Yes, the truth can be suppressed, as demonstrated by many previous oppressors, but it cannot be suppressed forever.
9. Justice is the founding principle of civilisation; it is more sacred than life itself. Without justice we are no more than roaming savages having no regard for humanity. In a Christian world, the greatest command of God to all Ruling Authorities is Not to Deny Justice to the People.

10. Justice belongs to all or it belongs to no one, it is the reward of the righteous and poison to the wicked. **Cowards fear justice and seek protection from behind closed doors or else they flee when justice is in pursuit.** Truth Fears No Evil, its only demand for justice to be done is perseverance and endurance.
11. I cannot be lead into violence, I simply have no need for it because Truth and Justice are on my side, however, **"It is both good law and good sense that a man who is attacked may defend himself. It is both good law and common sense that he may do, and may only do, what is reasonably necessary, but everything will depend upon the particular facts and circumstances. Of these a jury will decide"**
12. If my statement was not true and supported by overwhelming evidence I would have been written off as deluded, however, three separate doctors employed by the state in an attempt to section me, refused to violate their ethical and moral principles and instead confirmed the cruel and wicked injustice I have been subjected to over many years. Their reports are submitted in my files.
13. It is fast approaching five years since the State wrongfully convicted and imprisoned me **without the Right of Appeal** for an act committed in Self-Defence and in protest against many years of abuse by the Judiciary and other State officials. The State has further threatened to impose an additional 548 days imprisonment for **not being able** to pay an Order demanding £85,000 assumed to be available in alleged "hidden bank accounts"
14. The blood of my son is on the hands of all those who have deliberately conspired to obstruct justice. The separation from my other children and the suffering inflicted upon them through the wickedness of the above conspiracy will bear heavily on the conscience of those involved.
15. **We all know that a dead man cannot talk, but is the State now ready to commit Murder in an attempt to hide the Truth and Deny Justice.**
16. Decency, Security and Liberty alike demand that government and all its officials shall be subjected to the same rules of conduct that are commands to the citizen. Otherwise, we have a system governed by Hypocrites and a pathway to anarchy.
