FOLLOWING OUR TELEPHONE CONVERSATION 11 MAY,  
PLEASE FIND ENCLOSED COPY OF A JUDGEMENT HANDED  
DOWN BY THE COURT OF APPEAL WHICH SOLIDIFIES  
MY ARGUMENT OF BIAS OR APPARENT BIAS.

THE CLARITY OF THIS JUDGEMENT CONFIRMS THE ENTIRETY  
OF MY GROUNDS OF APPEAL WHICH WAS SUBMITTED WITH  
MY APPLICATION TO THE CCRC.

WHILST I FULLY APPRECIATE THAT YOUR COMPLAINTS PROCEDURE  
CANNOT OVERTURN A DECISION OF THE COMMISSION, HOWEVER  
WRONG, IT CAN HOWEVER, MAKE RECOMMENDATIONS THAT  
A DECISION SHOULD BE REVIEWED.

PERVERSION OF JUSTICE, PERJURY, CONCEALMENT OF EVIDENCE,  
AIDING AND ABETTING AND FALSE IMPRISONMENT ARE ALL  
CRIMINAL ACTS FOR WHICH THE JUDICIARY, THE COMMISSION  
ALONG WITH OTHERS COULD BE REPORTED, ETC. SO I  
STRONGLY SUGGEST THAT THIS MATTER BE LOOKED AT  
WITH THE LAW, AND ONLY THE LAW, IN MIND.


PLEASE NOTE THAT THE HOME OFFICE AND THE DEPARTMENT  
FOR CONSTITUTIONAL AFFAIRS HAVE PLACED THE ISSUES  
RAISED IN MY COMPLAINT FIRMLY AT YOUR DOOR AND  
ENTIRELY WITHIN YOUR STATUTORY REMIT.

UNLESS THIS MATTER IS RESOLVED ACCORDING TO LAW, I  
WILL HAVE NO CHOICE OTHER THAN TO REPORT THE CRIMINAL  
ACTIVITIES TO THE COMMISSIONER OF POLICE, CONSEQUENTLY,  
IF HE SHOULD FAIL TO INVESTIGATE AND PROSECUTE, HE TOO  
WOULD <sup>BE</sup> GUILTY OF ALL THE OFFENCES MENTIONED PLUS  
THE CRIMINAL ACT OF OBSTRUCTING JUSTICE.

IMPRISONMENT AND PAIN AND SUFFERING IS A HARSH PRICE TO PAY  
FOR BRITISH JUSTICE. I HAVE PAID THE PRICE, THEREFORE  
I DEMAND JUSTICE.

PLEASE ACKNOWLEDGE RECEIPT OF THIS LETTER AND ITS  
ENCLOSURES AND I LOOK FORWARD TO YOUR FULL RESPONSE  
EARLY JUNE.
