DEAR HOME SECRETARY,

FOLLOWING UP MY LETTER DATED 27TH MARCH 2006 AND
THE LETTER OF REFERRAL FROM BUCKINGHAM PALACE DATED
17TH FEBRUARY 2006, I WRITE FURTHER, AHEAD OF YOUR
REPLY, TO SUBMIT FURTHER UNCHALLENGEABLE EVIDENCE
WHICH SOLIDIFIES MY DEFENCE AND ARGUMENT.

THIS EVIDENCE COMES FROM THE BEST POSSIBLE SOURCE,
NONE LESS THAN THE VERY JUDICIARY WHICH IS MY MAIN
ADVERSARY IN THIS CASE. IT CONFIRMS THE LEGAL
REQUIREMENT TO CONFORM WITH THE PRINCIPLES OF
ARTICLE 6 OF THE EUROPEAN CONVENTION ON HUMAN
RIGHTS WHICH IS ALSO ENSHRINED IN OUR LAW HERE IN
THE UNITED KINGDOM. I AM ENCLOSED WITH THIS LETTER
A COPY OF A JUDGEMENT HANDED DOWN BY LORD JUSTICE
MUMMERY, LORD JUSTICE LATHAM AND LORD JUSTICE CARNWATH.

JUDICIAL IMPARTIALITY IS THE FUNDAMENTAL PRINCIPLE OF
JUSTICE AND THIS CANNOT BE ACHIEVED WHEN THE
JUDICIARY ARE JUDGES IN THEIR OWN CAUSE. MY CLAIM
IS AGAINST THE JUDICIARY, SO IT IS NOT POSSIBLE FOR
ME TO GET JUSTICE IN THE COURTS.

YOU MUST NOW USE THE SOVEREIGNTY OF PARLIAMENT TO

INTERVENE IN THIS UNPRECEDENTED CASE AND CALL A
STOP TO THE DISGRACEFUL INJUSTICE COMMITTED BY
MEMBERS OF THE JUDICIARY.

I HAVE BEEN CONVICTED AND IMPRISONED WITHOUT THE
RIGHT OF APPEAL, THE FACT THAT I HAVE BEEN DENIED
THE RIGHT TO CHALLENGE THE SAFETY OR LAWFULNESS
OF MY CONVICTION AUTOMATICALLY RENDERS MY ~~CONVICTION~~
CONVICTION UNSAFE AND THEREFORE UNLAWFUL, IRRESPECTIVE
OF THE ALLEGATIONS AGAINST ME, MY DEFENCE AT TRIAL OR
EVEN, MY GROUNDS OF APPEAL.

THE CRIMINAL CASES REVIEW COMMISSION HAS UTTERLY FAILED
IN ITS REMIT TO REVIEW THE ISSUES WITH AN INDEPENDENT
AND IMPARTIAL MIND. THE RESPONSIBILITY NOW FALLS ON YOU,
HOME SECRETARY, TO DEAL WITH THIS MATTER YOURSELF OR
TO SET UP AN INDEPENDENT PUBLIC INQUIRY INTO THE
FAILINGS OF THE JUDICIARY AND THE BODY SET UP WITH
ITS SOLE PURPOSE TO INVESTIGATE ALLEGATIONS OF MISCARRIAGES
OF JUSTICE.
