DEAR LORD CHANCELLOR,

SINCE MY LETTER TO YOU, DATED 31ST MAY 2006,
BRINGING TO YOUR ATTENTION A GRAVE PERVERSION
OF JUSTICE COMMITTED BY THE JUDICIARY, I'VE
HAD NO REPLY OR ACKNOWLEDGEMENT.

I CAN ONLY ASSUME THAT YOU REGARD THIS
MATTER AS ONE THAT CAN BE PUSHED "UNDER
THE CARPET".

I SHOULD, HOWEVER, REMIND YOU THAT IT WAS
THE IGNORANCE OF YOUR PREDECESSOR WHICH
ALLOWED THIS VERY GRAVE CRISIS TO ARRIVE AT
THE POINT WE ARE TODAY.

IF LORD IRVINE HAD NOT BREACHED HIS POSITION OF
TRUST AND HAD NOT IGNORED THE IN-DIRECT INTERVENTION
FROM HER MAJESTY THE QUEEN, THE PERVERSION OF
JUSTICE WOULD NOT HAVE CONTINUED UNABATED.

AS YOU WILL BE AWARE, A PERSON HOLDING AN OFFICE OF
TRUST CONCERNING THE PUBLIC, HOWEVER APPOINTED, IS
CRIMINALLY LIABLE TO THE KING/QUEEN FOR MISBEHAVIOUR
OR MISCONDUCT. ANY SUCH ACT IS PUNISHABLE BY IMPRISONMENT

AND OR AN UNLIMITED FINE. SO IN PLAIN ENGLISH,
A WILFUL BREACH OR NEGLIGENT BREACH OF A PUBLIC
DUTY IS A CRIMINAL OFFENCE.

WE ALL LIVE BY THE RULE OF LAW, IT PROTECTS
OUR SOCIETY AND OUR DEMOCRACY AND NO ONE IS
ABOVE IT. THE RULE OF LAW IS OUR ASSURANCE OF
JUSTICE, WITHOUT WHICH, WE CANNOT HAVE A DEMOCRACY.

I AFFORD YOU THE BENEFIT OF DOUBT THAT YOU
HAVE NOT PREVIOUSLY SEEN THE DOCUMENTED EVIDENCE
WHICH CONFIRMS JUDICIAL MISCONDUCT AND SUBMIT
THEM NOW FOR YOUR OWN PERUSAL.

THE EVIDENCE IS OVERWHELMING AND INDEFENSIBLE AND
I HAVE ATTEMPTED TO INCLUDE THE MOST RELEVANT
AT THIS JUNCTURE.


THESE INCLUDE: A SUMMARY OF THE JUDGES SUMMING
UP AT MY UNLAWFUL TRIAL, MY GROUNDS OF APPEAL
WITH SUPPORTED EVIDENCE AND CITATIONS, LETTER FROM
BUCKINGHAM PALACE CONFIRMING THE INSTRUCTIONS OF HER
MAJESTY, LETTER FROM THE FORMER LORD CHANCELLOR'S
DEPARTMENT CONFIRMING THE UNLAWFUL ACT OF MR
JUSTICE TOULSON, REPLY FROM THE EUROPEAN COURT
OF HUMAN RIGHTS, LETTER FROM MR STANLEY BEST, CHAIRMAN
OF THE BRITISH LEGAL ASSOCIATION, CONFIRMING THIS MATTER
TO BE "A MATTER FOR VERY SERIOUS CONCERN INDEED"
MEDICAL REPORT IN SUPPORT OF MY CASE, THE JUDGMENT
OF THE FULL COURT DENYING MY APPLICATION TO APPEAL
THE JUDGMENT BEARS NO RELATION TO MY GROUNDS
AND THE JUDGES HAVE DELIBERATELY LIED TO COVER
UP THE TRUTH, MY LATEST LETTER TO HER MAJESTY

AND THE REPLY.

I WILL PROVIDE COPIES OF THIS DOCUMENT TO THE FOLLOWING PERSONS: THE ATTORNEY GENERAL LORD GOLDSMITH THE COMMISSIONER OF POLICE SIR IAN BLAIR, THE DIRECTOR GENERAL OF THE B.B.C. MR MARK THOMPSON AND OTHER INDEPENDENT PERSONS OR ORGANISATIONS.

FINALLY I SAY THIS: TRUTH AND JUSTICE IS THE MORAL AND SPIRITUAL FORCE WHICH GUIDES AND PROTECTS ME FROM THE WICKEDNESS OF EVIL, I HAVE EXPRESSED THE HIGHEST RESPECT FOR THE RULE OF LAW AND NOW I HOPE YOU CAN AND BE BRAVE ENOUGH TO DO THE SAME.
